02. Late submission will not be entertained.
03. Last minute submission should be avoided. As such P.T. Lee CN Trust will not be responsible for any failures in submission of bids.
04. The vendors are expected to examine all instructions, forms, terms and other information in the tender documents.
Tender shall be submitted under two bids system viz. Technical bid and Financial bid separately in a sealed cover, as per the prescribed formats only. Failure to comply with these requirements may result in rejection of the bid.

06. Incomplete or conditional bids will be summarily rejected
07. If any vendor does not qualify in technical evaluation, the financial bid of the vendor will not be opened.

12. The successful vendor shall supply the prescribed hardware within 15 days from the issue of supply order.
13. The payment will be released after complete supply of material, installation and based on duly certified installation reports.
14. If the tenders opening day happens to be holiday, the same will be accepted and opened on the next working day.
15. The make / brand of the quoted hardware must be mentioned.
The warranty shall cover the following:

Scope of work

1. **Required Quantity:** At present **300 nos. of desktop computers** and **04 nos. of Servers** are required. Quantity may be increased / decreased as per requirements.
2. **Additional Requirement:** Vender should supply additional quantity as required by the P.T. Lee CN Trust in the near future. Rates should be valid for 3 months from the date of submission of tender.
3. **Supply of desktop computers:** The vendor has to deliver the desktop computers and ensure installation of the same along with related systems, at (a) P.T. Lee Chengalvaraya Naicker College of Engineering and Technology Ooverly Village, Kanchipuram Taulk, Kanchipuram District and at (b) Vallal P.T. Lee Chengalvaraya Naicker Arts & Science College, 5/1, General Collins Road, Choolai, Chennai – 600 112.
4. **Warranty of Desktop Computers:** The Vender has to ensure the warranty of all supplied desktop computers during the warranty period of three years.
5. **Replacement of parts:** The vendor has to assure rectification of the faulty desktop computers, providing replacement for the same as per requirements.
6. **Annual Maintenance Contract:** AMC Fee for five years after the warranty period shall be quoted separately.

2. Proof of income tax, GST registration number (as applicable): Self attested copies to be attached.
3. The product profile of the company along with last 3 years turnover not less than 100 lakhs. Audited balance sheet and profit and loss account or CA certificate for last three years should be submitted.
4. The vendor shall be Original Equipment Manufacturer (OEM) of desktop computers and peripherals or the authorised system integrator / channel partners / dealer of OEM. In case the vendor is offering desktop computers from more than one OEM, he shall be authorised system integrator / channel partner / dealer for the desktop computers and peripherals offered by him. Proof of the above shall be submitted in the form of authorization of dealership / SI / Partnership issued by the respective OEM.
5. The vendor should have office at Chennai, fully functional service / support centre.
6. The vendor should have successfully supplied hardware amounting to minimum of Rs.60 lakhs to at least one customer in Government department or public undertaking or private sector in Tamilnadu in the last 3 years. Purchase order and proof of satisfactory service from the customer shall be attached.
7. The company / firm should be in existence and should have been in operation for a period of at least 3 years. The company / firm have to produce certificate of incorporation / registration.





